The following Rules are designed to ensure that everyone has an enjoyable visit in a caring and comfortable environment. By clicking the link below and applying for a password you agree to these terms.

### BOOTING (A one hour ban)

You may be booted for the following reasons:

1. Using Vulgarity or words considered vulgar are prohibited. Words that are sexually explicit in nature may be deemed vulgar. Please be respectful of other visitor's gender, ethnic or religious backgrounds, and sexual orientation. Please Note: Masking vulgarity, by substituting typed characters (i.e.. # or \*), does not avoid the vulgar intent nor the enforcement of our policies.
2. Abusive behaviour, room disruption and harassment of our visitors and staff is strictly prohibited. While we understand the need for lively debate when topic allows, please address the issues and not the person who disagrees with you. Name-calling or any other means to make your fellow guests uncomfortable will be considered harassment.
3. Dating or cyber-sex.
4. Giving reading that we consider to be inappropriate or frightening. You will be warned in the first instance but may be ejected if you refuse to comply with our staff's instruction.

### BANNING (Permanent Ejection)

You may be banned for the following reasons:

1. Solicitation of our visitors and staff. This includes posting URL's or encouraging staff or visitors to visit other chatrooms.

2. If you work as staff on any of the sites, we have on our banned list. This includes a number of hate sites, satanic sites, evangelical sites and sites established by staff we have sacked. If you have a chatroom get your traffic legitimately and on your own merits and not by acting as a parasite on our site!

3. Impersonation of Craig & Jane Hamilton-Parker or any web site staff will not be tolerated.

## TERMS of SERVICE AND MEMBERSHIP AGREEMENT

### GENERAL TERMS APPLICABLE TO ALL MEMBERS:

These terms apply to QKE Ltd. chatrooms, discussion rooms and other online services (the "Services" or the "Service" ) to members who have registered in respect of those services. Your use of the Services is subject to our Code of Conduct and to these membership terms and conditions, and the Code of Conduct is hereby incorporated into these membership terms and conditions by this reference.

All Memberships take the form of a non-transferable license to use the Services and can be revoked by QKE for serious or persistent failure to abide by these terms and conditions.

By gaining access to and logging into any members area:-

You confirm that you are over 18 years of age.

You agree you have read and understood and agree to abide by these terms and conditions which are presented to you for approval before you make your decision to participate or purchase a membership.

You confirm (where applicable) that you have intentionally purchased membership to the subscription area of the site for the time period you selected.

You also agree that you are taking full responsibility for your actions in joining the members site and will not take any legal action against the webmaster/host(s), or any other connected parties, based on your decision to join.

You confirm that you are not being forced by anyone to join against your will.

#### **SPECIFIC TERMS APPLICABLE TO SUBSCRIPTION (ELYSIUM) MEMBERS:**

QKE takes considerable care to ensure that subscription based members enjoy a positive and productive environment for the teaching and discussion of spiritual and psychical matters. To this end users are offered an exclusive license to use the services not the right to continuing access regardless of their behaviour in the forum(s).

By making use of the subscription area(s) your first payment becomes non-refundable as you have received access to the website. If you have signed up for 1 month this means 1 months fee will be charged and is not refundable. The same is true of a purchase for 12 months membership. By logging on you are committing yourself to the term you have paid for.

In general refunds for membership are not entertained except for:

Mistaken Transactions (before the account is activated / used);

Fraudulent Transactions;

Any mistaken or incorrect billing amounts;

Life Membership. QKE will, at our sole discretion, determine what proportion off the membership fee is refundable based on the amount of administration required to initially set up and subsequently revoke a Life Membership, including, but not limited to, expenditure of time and resources on investigating any claim that lead to the revocation of Life Membership.

You may cancel any time you wish as long as you do so before the next automated billing cycle occurs. Cancelling stops re-billing -it does not create a refund.

#### **MEMBERSHIP AGREEMENT**

6.2 QKE Ltd. has no liability or responsibility to Members for performance or non-performance of monitoring activities.

QKE Ltd. reserves the right to suspend or expel Members and prevent their further access to the Services for violating these membership terms and conditions or the Code of Conduct or the law and further reserves the right to remove communications which are abusive, illegal, defamatory, disruptive or otherwise contravene the Code of Conduct.
